Director of Further Education and Training Update

We hope to have a new Director of FET appointed this week. Our focus has been on the reopening of and guidance for FE and HE institutions which require the 2m social distance (FET guidelines document developed by ETBI). We have worked hard to meet the requirements in all FET settings and are reopening gradually over the next number of weeks.

Learner starters, year-to-date, are reasonably strong. We have achieved over 50% of our revised numbers. However, in September 2019, over 9,000 FET learners started in DDLETB. This year, that number will be significantly reduced by circa 50%. We will be working closely with the DEASP.

A very positive article in the Irish Times on Saturday highlighting the opportunities this year in DDLETB.

The Quality Council has been meeting regularly to approve contingency plans to address issues in delivery and assessment in light of the COVID-19 lockdown and reopening with enhanced measures.

The legal advice that circulated to you will be reviewed (as further clarity will be received from ETBI) at our next Board Meeting. Any questions you may have can be noted today and we will bring the responses to the next meeting. At that session, a summary of the reserved and executive functions will be outlined, the differences between the primary and post primary BOMs will be summarised and equally the role and responsibilities of members of BOMs for ETB Schools which are different from non-ETB Schools.

The last six months have proven to be very challenging for all school and centre leaders within DDLETB. However, the challenge was overcome due to the leadership and support that was provided within the ETB. The collegiality among staff is noteworthy and as a collective, we will continue to work together and with the Board to remain open safely and
